Marine Safety Information:

-Stolen boats and motors: Recent thefts of boats and motors from storage areas in central Florida have remained unreported for months due to owner's neglect. A thief with a stolen boat and its trailer was stopped by the police and released because the theft of the boat in question had not been reported and the owner had no knowledge that his boat had been stolen. The Coast Guard recommends that boat owners should check their stored boats as frequently as possible or have the manager of the storage area to check the boats for them. A stolen outboard motor worth \$ 6,000.00 was sold on Craig's list for the price of \$ 500.00. If you see a listed deal "too good to be true" it may be a stolen item. Mercury Marine maintains a database of motors reported stolen available to prospective buyers of Mercury engines.

Safe Boating is a Choice

Yes, safe boating is a choice and we need to do more to make the public aware of it. Somehow we must impress upon the public that when acquiring a boat, especially for the first time, that they should be properly prepared.

Here are some facts taken from the 2010 Boating Accidents Statistical report compiled by the Boating & Waterways Section of the Florida Fish & Wildlife Conservation Commission (FWC):

- The State of Florida has the highest number of boating accidents AND boating fatalities in the entire United States.
- The majority of accidents occurred in small open motor boats.
- 66% of the operators in boating accidents had NO boater education.
- 73% of these operators were over 22 years old. Thus they were not mandated by law to take a course.

The above information should inspire all USPS members to increase their efforts to enroll their boating acquaintances in the Americas Boating Course. After all, the mission of USPS is to save lives. Do you know when your squadron is having its next ABC course?
